#### FOR THE SUPPLY OF ANKLE HIGH SHOES ALONG WITH UPPER & LOWER

Municipal Corporation Shimla intends to purchase the following items:

1. Good quality ankle high shoes (1500 No.) with superior quality rubber sole and inner woollen lining of different sizes as per MC demand.
2. Upper/Jacket/Zipper with hood (1500 No.), full sleeves, two pockets, single textured polyester make with PVC coating on the inner side, zipper at the centre of different sizes, special inner taping along stitches for total water protection along with lower (with fluorescent glowing lining/taper on both shoes and lower also) having different sizes as per MC demand.

## **Submission of Bids:-**

### **(A) Technical bid shall contain following documents.**

**The Technical Bid shall be submitted in a sealed envelope and it should be marked as**

- I. Tender document shall be accompanied with the Earnest Money Deposit of Rs. 50,000/- (Fifty Thousands) only in the shape of Demand Draft issued in favour of "The Commissioner, Municipal Corporation Shimla" payable at any nationalized/scheduled bank at Shimla.
- II. Tender document without EMD shall be rejected summarily.
- III. Successful bidder will have to deposit additional Rs. 50,000/- (Fifty thousands) only as Performance Security against the total amount of Rs 1.00 Lakh and remaining Rs. Fifty Thousands already deposited as EMD shall be treated as Performance Security on behalf of successful bidder at the time of executing contract for the supply of above mentioned items.
- IV. No interest whatsoever shall be paid on the amount of Performance Security deposited by the agency/bidder.
- V. Successful bidder shall have to supply all the awarded items within one month time positively from the date of issue of work order. Any delay beyond this shall attract a penalty @ Rs. 5,000/- per day and if the items are not supplied within 45 days, the EMD shall be forfeited.
- VI. Copy of Certificate of manufacturer/distributor/authorised dealer shall be enclosed.
- VII. Copy of the PAN No and GST No should be enclosed.
- VIII. The Bid without submission of samples of items to be supplied shall not be considered. It is mandatory to supply samples alongwith bid document.


### **(B) Financial Bid:-** Financial bid shall contain following documents.

The Financial Bid should be submitted in separate sealed envelope and shall be marked as Financial Bid on the top of the envelop. The financial bid of only those bidders shall be opened who will qualify in the Technical bids and the sample of item shall be accepted the Committee

- I. The Financial Bid should clearly mention rates per item separately inclusive of all taxes and F.O.R. MC Shimla store.

- II. The successful bidder shall ensure that no damage is caused to any item during transportation and if any item is found damaged, the same should be replaced immediately within the time limit granted above.

The Municipal Corporation Shimla will not be responsible for delay in transit/damage/loss of bid documents sent by post. Commissioner, MC Shimla reserves rights to accept/reject the tenders without assigning any reason.
