Terms & Conditions:

- SCOPE & SPECIFICATION OF WORK: The scope and specification of work shall be as detailed in BOQ.
- TENDER DETAILS: The e-tender Documents shall be uploaded online in two Covers:
 - (i) Cover-1: shall contain scanned copies of all "Technical Documents/ Eligibility Information".
 - (ii) Cover-2: shall contain "BOQ/Financial Bid", where Contractor/firm will quote his offer for each item.
- 3. SUBMISSION OF ORIGINAL DOCUMENTS: The bidders are required to submit (a) original demand draft towards the cost of bid

document and (b) original bid security/Earnest Money Deposit (EMD) and other Technical Documents in O/o Executive Engineer, Road & Building Department M.C. Shimla, H.P. as specified in Key dates Sr. No. 4 on Tender Opening Date, failing which the bids will be declared non-responsive.

- 4. BID OPENING DETAILS: The bids shall be opened on 19.06.2021 at 2.00 PM in the office of Executive Engineer, R&B M.C. Shimla H.P. by the authorized officer. In their interest the tenderer are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 5. FINANCIAL EVEALUATION: Financial proposals shall be opened only for Technically Qualified Bidders. Bidders shall be required to quote rates for the complete scope of work as detailed in BOQ. The bidder shall quote on item rate basis against the items mentioned in the BOQ. Bidder with the lowest quote rate shall be declared L-1 bidder.
- 6. WARRANTY: The bidder shall provide three year onsite warranty for the equipment to be supplied under this tender. Bidder must have Local Registered Service Office in Himachal Pradesh in case any complaint can be attended within 24-48 hours.
- Certificate from National Accreditation Board for Testing and Calibration Laboratories (NABL) for Metal Tensile, Class & Thickness Test, FRP & ROTO Dimension & Thickness Test, and Bearing Test Certificate & Rope Load Bearing/Strength Test as per tender specification. Bidder shall submit product literature of all equipments. Bidder must submit valid ISO Certificate, GS Certificate (German Product Safety Law), European Norms Certificate (EN) & Compliance Certificate of the OEM relating to Open Air Gym/Outdoor Fitness Equipments. Bidder shall also provide OEM (Original Equipment Manufacturer) certificate for the equipment to be installed under this tender. In case bidder have not OEM (Original Equipment

Manufacturer), the bidder must submit manufacturer's authorization certificate from the OEM along with the following documents:-

- Factory license of the OEM.
- OEM Company registration certificate, GST and PAN Card.
- 8. PERFORMANCE SECURITY: The successful bidder shall furnish performance security equal to 10% of the contract amount at the time of the receipt of notification of award from the Employer. The performance security may also be submitted in the form of FDR in favour of "Executive Engineer, R&B, M.C. Shimla. The performance security shall be kept 60 days beyond the completion of 3 years Defect Liability Period (DLP).
- The bids for the work shall remain valid for acceptance for a period not less than 120 days after the deadline date for bid submission.
- 10. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to the tender.
- 11. The Contractors/firms must maintain a wage register/Mustrol at the site of work place and it should be verified from time to time by the inspecting authorities, alongwith any award of work order/documents. Any default by the Contractors/ firms will render him in-eligible for future participation in the tendering process, for failure to comply with the mandate of the provident fund organization and for furnishing wrong information.
- 12. The Contractors/firms must give photocopy of Enlistment/Registration Certificate, Goods & Service Tax (GST) number, EPF Number, individual/firm PAN Number as proof allotted to them with their application at the time of applying for tender documents. Application will not be entertained without aforesaid documents.

- 13. E-tenders will be accepted only from those contractors/firms who have successfully executed minimum similar work i.e. providing and Fixing Open Air Gym/Outdoor Fitness Equipments to any Government/Semi-Government Department or any other organization in last two years anywhere in India. Work completion certificate/performance certificate must be submitted in this regard. The certificate must have value of the work executed, start and end date of the project and scope of work executed by the bidder.
- 14. The bidders should have minimum average annual financial turnover of Rs.50.00 Lacs in last two Financial Years. The bidders shall provide financial turnover of the firm for the last three years duly certified by the CA along with 3 years audited annual accounts for financial year ending 2020-2021.
- 15. Bidder has to do the complete installation of instruments/equipments as per technical specification as detailed in "BOQ". The bidder shall make his own arrangement for transport of all materials. M.C. Shimla will not be responsible for any damage that occurs to the equipment prior to issuance of acceptance certificate by the Department for the goods installed at site.
- 16. If Department is performed test of supplied equipment randomly from any approved National Accreditation Board for Testing and Calibration Laboratories (NABL) in India, the contractor/owner of firm have to bear the cost of testing.
- 17. Bidder must submit an affidavit to the effect that the contractor/owner of firm/company has not been blacklisted/debarred/banned by any Govt., Semi-Govt. Department, or any other organization in past.
- 18. The contractor/firm shall abide by all the terms and conditions laid down in the tender Form MW-7 and the contractor/firm must upload scanned copy of Tender Notice & Form MW-7 duly signed with the bid online and must submit hard copy of these documents at the time of physical submission otherwise online bid will not be entertained.

- 19. The tenders of contractors/firms who failed to fulfill the eligibility information will be summarily rejected.
- 20. Earnest money of L1, L2 and L3 may be retained for a period of 90 days.
- 21. Tender Opening Committee reserves right to cancel or reject any tender or tenders without assigning any reasons.
- 22. Bidder shall have submitted original certificates as required on the demand of Technical Evaluation Committee. Unclear and unreadable documents shall not be entertained and shall be straightway rejected.
