- 3. Any tax if leviable shall be paid by the successful bidder.
- 4. All articles/items will be sold on "AS IS WHERE IS BASIS" (item wise) will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of the articles/items proposed to be auctioned.

- 9. The successful bidder will be required to make full payment by way of Demand Draft/Banker's Cheque payment at State Bank of India, Shimla in favour of Additional Commissioner, M.C. Shimla within 03 days

positively after receipt of notification of award. If the highest bidder/successful bidder fails to deposit the sale price within stipulated time, his Bid Security/EMD amount will be forfeited and auction will be treated as cancelled. In case the offer is withdrawn by any bidder, the Bid Security/earnest money deposited by him shall also be forfeited.
