- 4. EARNEST MONEY DEPOSIT: The earnest money shown above will be received in shape of Fixed Deposit Receipt (FDR) of a Nationalized bank duly pledged in the name of Executive Engineer, R&B, M.C. Shimla and Cost of tender will be received in shape of Demand Draft drawn in favour of Executive Engineer, R&B, M.C. Shimla. Exemption of bid money shall not be allowed. The tenders of those Vendors/Art Contractors who do not deposit the Earnest Money and Cost of tender in the prescribed manner will not be opened and will be summarily rejected. Earnest money of L1, L2 and L3 shall be retained for a period of 120 days.
- 5. **TENDER DETAILS**: The Tender Documents shall be uploaded online in 2 Cover: (i) Cover-1: shall contain scanned copies of all "Technical Documents/ Eligibility Information". (ii) Cover-2: shall contain "BOQ/Financial Bid", where contractor will quote his offer for each item.
- 6. **SUBMISSION OF ORIGINAL DOCUMENTS**: The Vendors/Art Contractors are required to submit (a) original demand draft towards the cost of bid document and (b) original bid security/Earnest Money Deposit (EMD) and other Technical Documents in the O/o Executive Engineer, Road & building Department M.C. Shimla, H.P. as specified in Key dates Sr. No. 4 on Tender Opening Date, failing which the bids will be declared non-responsive.

- 7. BID OPENING DETAILS: The bids shall be opened on 08.06.2023 at 03.00 PM in the office of Executive Engineer, R&B M.C. Shimla H.P. by the authorized officer. In their interest the Vendors/Art Contractors are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 8. **FINANCIAL EVEALUATION**: Financial proposals shall be opened only for Technically Qualified Vendors/Art Contractors. Vendors/Art Contractors shall be required to quote rates for the complete scope of work as detailed in BOQ. The Vendors/Art Contractors shall quote on item rate basis against the items mentioned in the BOQ. Vendors/Art Contractors with the lowest quote rate shall be declared L-1 bidder.

## 9. GENERAL CONDITIONS:

- (i) The Vendors/Art Contractors should be expertise in the artwork. They have done artwork successfully in Himachal Pradesh previously. Also they have done artwork in underpass Tunnel (traffic public place) or similar places. They should be able to submit profile with details of similar works done previously.
- (ii) The Vendors/Art Contractors should have experience for carrying out thematic wall painting, submitting theme note with photos successfully.
- (iii) The Vendors/Art Contractors should have National Level Art Done Appreciation Certificate in the last 2 years.
- (iv) All statuary deductions such as GST/Income Tax/Labour Cess or any other statuary levies as levied by Govt. of Himachal Pradesh or Govt. of India from time to time shall be payable and deducted from the bills of Vendors/Art Contractors at the prescribed rates and Govt. will not entertain any claim whatsoever on this account.
- (v) If the successful Vendors/Art Contractors fails to carry out the work within stipulated time after receipt of Letter of Award (LOA), the bid security/EMD amount will be forfeited and tender will be treated as cancelled. In case the offer is withdrawn by any Vendors/Art

Contractors, the Bid Security/Earnest Money Deposited shall also be forfeited.

The tender shall be subject to the Indian laws and jurisdiction of the (vi) Courts located in Shimla.
