Sealed item rate tenders are invited for the following works on behalf of Municipal Corporation Shimla from the eligible registered Electrical Contractor of H.P.P.W.D. & I.P.H. in appropriate category on the prescribed Form M.W. - 7. Tenders can be had from the office of the undersigned on any working day against cash payment of Rs. 350/- up to **11.30 AM** on or before **29.12.2023**. The tenders must be sent/deposited into the tender box with the proper sealed cover super scribed as "TENDER FOR _____" (Name of work) and shall contain name and address of the tenders. Tenders will be received on **29.12.2023** up to **11.30 PM** and shall be opened at **2.00 PM** on the same day in the presence of the contractors or their authorised representative who may like to be present.


1	Supplying and Fixing AC Rope lights 1200 Strips (IP653000K) 50mm for Decoration of trees and facials of building as per directions of Engineer-in-charges at various location in Ridge area from takka Bench to Daulat Singh Park area Shimla (Havells Make), Amount put to tender Rs.4,98,940/-, Earnest Money Rs.10000/-, Time limit within 3 days after award of work.
2	Supplying and Fixing AC Rope lights 1200 Strips (IP653000K) 50mm for Decoration of trees and facials of building as per directions of Engineer-in-charges at various location in Daulat Singh Park to Mall road Shimla (Havells Make), Amount put to tender Rs.4,98,536/-, Earnest Money Rs.10000/-, Time limit within 3 days after award of work.

CONDITIONS:-

1. Tender not received on prescribed form and manner shall not be considered and will be liable for rejection straightway.
2. The tender documents will be issued to only those firms/contractors (a) Who possess valid G.S.T. Number as applicable (b) Who posses latest tax clearance certificate issued by the Excise & Taxation Department (HP) & (c) who possess EPF Number and list of the person on whose basis, contractor had obtained EPF Number.
3. The Contractors must maintain a wage register/Mustrol at the site of work place and it should be verified from time to time by the inspecting authorities, alongwith any award of work order/documents. Any default by the contractor will render him in-eligible for future participation in the tendering process, for failure to comply with the mandate of the provident fund organization and for furnishing wrong information.
4. The contractor must give the photocopy of Enlistment, G.S.T. Number, EPF Number and photocopy of individual PAN Number allotted to them with

their application at the time of applying for tender documents. Application will not be entertained without aforesaid documents.


5. The Contractor shall abide by all the terms and conditions of tender Form MW-7 (Item Rate Tender and Contract for Works General Rules and Direction for the Guidance of Contractors).
6. The earnest money in the shape of N.S.Cs/Time Deposit Accounts/ Saving Accounts/ F.D.Rs in any of the Post Office/Nationalised Bank in HP duly pledged in favour of the Executive Engineer M.C. Shimla will be received along with the applications for obtaining the tender forms. The applications received without earnest money shall summarily be rejected.
7. Telegraphical/conditional tenders shall not be accepted.
8. Sale of tender form will be stopped at 11~~30~~ AM on **29.12.2023**
9. The validity period of the tenders is one hundred twenty days. (120 days).
10. Form will be issued to the contractor having experience of similar work.
11. The Corporation reserves the right to reject any or all tenders without assigning any reasons.
