In Exercise of the powers conferred by section 37 the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014), Subject to the provisions of this Act or any rule or scheme made there under, the Shimla Municipal Corporation, hereby makes the following bye-laws for street vending, namely:--

CHAPTER—1 PRELIMINARY

- 1. Short title and Commencement
- a) This Bye-law may be called The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Bye-laws 2024 for Shimla Municipal Corporation.
- b) It shall come into force on such date, as notified in the Official Gazette, by the appropriate Government.
- 2. Definitions. In these bye-laws, unless the context otherwise requires:
- a) "Act" means the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 Of 2014);
- b) "Appropriate Government" means the Government of Himachal Pradesh;
- c) "Bye-laws" means the bye- laws made under section 37 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act,2014,
- d) "Festive market" means a market where sellers and buyers have traditionally Congregated for the sale and purchase of products or services during festival season of the city or town and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- e) "Grievance Redressal Committee" means a committee constituted by the Government of Himachal Pradesh under sub-section (1) of section 20 of the Act;
- f) "Heritage Market" means a market which has completed more than fifty years in one place where sellers and buyers have traditionally congregated for the sale and purchase of products or services and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- g) "Holding capacity" means the maximum number of street vendors who can be accommodated in any vending zone and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- h) "Local authority" means Shimla Municipal Corporation.
- i) "License" means certificate of vending.
- j) "Mobile vendors" means street vendors who carry out vending Activities in designated area by moving from one place to another place vending their goods and services;
- k) "Municipal Commissioner" means the commissioner of the Shimla Municipal Corporation, Himachal Pradesh;
- "Natural market" means a market where sellers and buyers have traditionally congregated for the sale and purchase of products or services and has been determined as such by the local authority on the recommendations of the Town Vending Committee;

- m) "Niche market" means a market where sellers and buyers have traditionally congregated for the sale and purchase of niche products or services and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- n) "Night bazaar" means a bazaar where sellers and buyers have traditionally congregated for the sale and purchase of products or services after evening i.e. during night and has been determined as such by the local authority on the recommendations of the Town Vending Committee.
- o) "Notification" means a notification published in the Official Gazette and the term "notify" shall be construed accordingly;
- p) "Plan" means plan prepared under section 21 of the Act;
- q) "Planning authority" means an Urban Development Authority or any other authority in any city or town designated by the appropriate Government as responsible for regulating the land use by defining the precise extent of areas for any particular activity in the master plan or development plan or zonal or layout plan or any other spatial plan which is legally enforceable under the applicable Improvement trust Act or the Municipal Act, as the case may be it Act;
- r) "Public purpose" includes in the context of the Act
 - (i) Widening of roads, Streets, lanes;
 - (ii) shifting the alignment of roads, streets, lanes;
 - (iii) erecting flyovers with or without clover leaves and slip down roads;
 - (iv) erecting of underpasses;
 - (v) development of land owned by public authorities for some public projects;
 - (vi) laying of water, storm water or sewer lines;
 - (vii) erecting intermediate pumping stations for the services;
 - (viii) any project related with public transport like BRTS, Metro, etc;
 - (ix) erection of Economically Weaker Section (EWS) Housing;
 - (x) Creation of Parks, Gardens and Recreational Area;
 - (xi) Conservation of any eco system resource in that area and
 - (xii) Any other developmental work taken by the local authority, the beneficiary of which will be the community at large.
- s) "Scheme" means Himachal Pradesh Street Vendors (Protection of Livelihood and Regulation of Street Vending) Scheme, 2017.
- t) "Seasonal market" means a market where sellers and buyers have traditionally congregated for the sale and purchase of products or services during specific seasons and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- u) Section" means sections of the Act;
- v) "Stationery vendor" means street vendors who carry out vending Activities on regular basis at a specific location;
- w) "Street vendor" means a person engaged in vending of articles, goods, wares, food items or merchandise of everyday use or offering services to the general public, in a street, lane, side walk, footpath, pavement, public park or any other public place or private area, from a temporary built up structure or by moving from place to place and includes hawker, peddler, squatter and all other synonymous terms which may be local or region specific; and the words" street vending" with their grammatical variations and cognate expressions, shall be construed accordingly;
- x) "Registered Street vendor" means a person engaged in street vending as per' the Act and is registered with Shimla Municipal Corporation under Street Vendor Act 2014.

- y) "Town vending committee" means the body constituted by the appropriate Government under section 22 of the Act.
- z) "Vending zone" means an area or a place or a location designated as such by the local authority, on the recommendations of the Town Vending Committee, for the specific use by street vendors for street vending and includes footpath, side walk, pavement, embankment, portions of a street, waiting area for public or any such place considered suitable for vending Activities and providing services to the general public.
- aa) Violation "means an Act committed by vendor which contradicts the conditions given in the License/ Certificate of Vending.
- bb) "Weekly market" means a market where sellers and buyers have weekly congregated for the sale and purchase of products or services and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- cc) Words and expressions defined in the Act and used in these Bye-laws shall have the same meanings as respectively assigned to them in the Act.

CHAPTER-II MANNER OF VENDING IN DIFFERENT VENDING ZONES

- 3. REGULATION AND MANNER OF VENDING IN DIFFERENT VENDING ZONES-
- a) Vending Zone: TVC shall have to decide about vending zones considering its heritage value and sanctity alongwith an intensity of foot falls, nature of road, Road width and vehicular & pedestrian movement in the city.
 - I. There shall not be any restriction-fee-vending zones in the city. Carrying capacity of an area would put the ultimate limit on the number of street vendors which can he positioned in any area. However, there shall not be any restriction on mobile vending in these areas except in the core area of Mall road and historic Ridge and its adjoining areas in order to protect its legacy and heritage value, if venders continuously move, without affection traffic and commuter movement. In such case TVC has to decide the total number of such mobile vendors who can be accommodated after taking into account the area of significant footfall and 1/3 of the holding capacity of the area; otherwise there is a chance of creating problem for traffic movement, as the mobile vending invariably takes place from the carriage way.
 - II. Mobile vending is only allowed on vending streets as specified by TVC Shimla.
 - III. In no circumstances street vender's number will increase above 2.5% population of particular ward of SMC.
 - IV. Minimum 1 meter space for pedestrian movement and also for the movement of emergency vehicle need to be ensured in front of vending area and road. This area need to be kept free from any kind of obstructions, which has also been directed from time to time by Hon'ble High Court in CWPIL 14 of 2014.
 - V. It shall be the duty of the designated official of the local authority to keep a check the number or mobile vendors shall not cross the limit at a specific place as decided by the town vending committee.
 - VI. Local Seasonal vegetable vendor shall be provide the space in different places without vending fees.

- b) The restricted vending zones are mainly linked up with the road width, and the roads of the following description have been put in this category in the plan;
 - (i) There shall not be any stationary street vending on a road having width equal to 3 meter. However, after due approval from the Town Vending Committee. One side street vending shall be allowed if such road is declared as no vehicular road subject to plybility of emergency vehicle.
 - (ii) There shall not be any stationary street vending on a road having width between 5 meters to 8 meters. However, after due approval from the Town Vending Committee one side street vending shall be allowed if such road is declared as one way vehicular road.
 - (iii) Number of street vendors shall be decided by considering holding capacity of each designated vending area on such a road.
 - (iv) Such stationary vending shall be allowed after taking the clearance from traffic police regarding the smooth vehicular and pedestrian movement. If required, road side parking shall be banned in such area where street vending is allowed.
 - (v) Mobile vending shall be allowed on such road after consideration to the traffic and pedestrian movement.
 - (vi) Suggestive road designing is attached as Annexure.

c) No Vending Zone:

- (i) No vending shall be allowed around 100 meters of the secretariat, core area of Mall, District Secretariat, Municipal Corporation, Military Command Est. and state archeological monuments.
- (ii) No vending within 25 meters from any crossing of two or more roads on all side and any declared heritage structures by the local authority. No vending zone Lakkar Bazar before & opposite old Regal bldg. near Ridge, Opp. Manchanda pedestal path, on Terrace of Public toilet at IGMC road, Longwood near RKMV Cart Road, Revoli road to in front of Lower Bazar Tunnel, Grand Hotel gate to Kali Bari road, Tara Hall to Kaithu Bazar, Cherateen road S/Hill, Near HPU Model School Summer hill, Lower Summer hill chowk nr. Police Chowki, MC Parking Tutikandi bye pass to old barrior, All Foot over bridge at Shimla, Near Tourist Hotel to Ram Mandir Gate, Public toilet nr. Nathu Halwai, Opposite Mehru Halwai, Adjoining shere Punjab Dhaba nr. Mall to Seven Eleven, Adjoining lift Mall road and in front of PNB branch, Sanjauli Bazar Cart road, Sanjauli Bazar near Gurudwara Cart road, Dhalli Tunnel nr. Cemetary road, Near way to SDA Chowk Bye Pass road and Foot path and Near Mahila Thana BCS to New Shimla road.
- (iii) No vending shall be allowed around 50 meters on both the side form the entry and exit of any educational institutions and hospitals.
- (iv) No mobile vendor shall not be allowed in heritage area.
- (v) No vending zone shall be implemented in front of any shop in MC Shimla Jurisdiction.

- 4. Restrictions on street vendors.
 - a) A Street vender, who got street vending certificate for any of these vending zones, shall not --Obstruct or interfere with vehicle, bicycle or pedestrian traffic of their safety;
 - b) Obstruct of interfere with doorways, entrances, fire doors or emergency exits adjacent to the street;
 - c) Obstruct or interfere with any utilities like water supply, sewerage, telephone, electricity etc or similar installations;
 - d) Obstruct or interfere with any other structures, sign boards, display units, city works or operations, on or adjacent to the street;
 - e) Sell any prohibited, objectionable/pirated goods or services or merchandise etc; as per rules, regulations and notifications issued by any statutory authority from time to time.
 - f) Occupy more space than allotted space by the TVC/SMC;
 - g) Sell goods or services or merchandises after fixed hours as specified by the TVC;
 - h) Dispose garbage in an un-segregated manner and in any place other than specific place which is identified by the local authority.
 - i) Sell the goods or services or merchandises after expiry of the vending certificate;
 - j) Sell any product in unhealthy and unhygienic condition with poor quality and which as hazardous for human health.
 - k) Use of loudspeakers, megaphones, sound systems or other amplification equipment;
 - Allow any person other than family member to vend from his vending place or sublet the place, allotted by local authority.
 - m) Use any unauthorized and prohibited mechanism for energy requirement in public place, crowded area for cooking and heating purpose example open tandoor and domestic LPG.
 - n) Construct any permanent or temporary structures on allotted space.
 - o) Use banned polythene bags of any kind.
 - p) Transfer the certificate to any other vendors without approval.
- 5. Responsibility of Street Vendors- It shall be the duty of the street vendors or his family members or employee to;
 - a) Comply with all the conditions specified in the certificated of vending.
 - b) Comply with all the conditions specified in The street Vendors (Protection of Livelihood and Regulation of street vending) Act, 2014 HP, SV rules- 2016 & HP SV, Scheme, 2016 along with direction given by any court of laws from time to time those are left out form these Bye laws.
 - c) Do vending on the place as specified in the vending certificate.
 - d) Comply with all conditions specified in the certificate;
 - e) Prominently display ID card & Certificate of vending at vending place all times.
 - f) Ensure that either the street vendor or such family member whose name has been mentioned in the vending certificate or employee remains present at vending place during vending hours;
 - g) Keep the vending place safe and in good conditions all times;
 - h) Comply with any safety and or sanitary requirements of local authority i.e SMC and any other line department of HP.
 - i) Produce the certificate of vending when demanded by any of the Government authority;
 - j) Comply all the requirements of the Food Adulteration Act or any other act if applicable;

- k) Clear and remove, wares and articles every day at the end of vending hours from the site, no storage at vending site id permitted in any manner other than the facility developed by the local authority;
- Use recommended fire safety devices/ equipment's in case of registered food street vendors for heating purposes by using commercial LPG connection and also in case of other vendors selling combustible products.
- m) Comply to Bye laws framed by Shimla Municipal Corporation for Door to Door Garbage Collection and Disposal, 2018.
- n) Follow all the requirements of this bye-laws and conditions mentioned in the vending certificate.

CHAPTER-III

FEES, TAXES AND PENALTIES AND TERMS & CONDITIONS

- 6. Vending Fees- Every registered street vendor shall be liable to pay vending fees as prescribed by TVC from time to time as per Himachal Pradesh Street Vendors (Protection of Livelihood and Regulation of Street Vending) Scheme, 2016.
- 7. Fee for amenities and facilities Every registered street vendor shall be liable to pay fee for amenities, facilities and maintenance charges e.g drinking water, sanitation, public convenience, storage/refrigeration store etc as prescribed and provided by the local authority from time to time and as applicable.
- 8. User Fee/charges: Every registered street vendor shall be liable to pay fee/charges as per Door to Door Garbage Collection and Disposal Bye laws, 2018 of Shimla Municipal Corporation.
- 9. Penalty to be levied
 - a) Every registered street vendor who commits violation of the provisions of the street Vending Act/ Rules or Bye laws, shall be liable for penalty as per the following table:

- b) If registered street vendors violates any provision of the act/ bye laws five times, then the vending certificate will be cancelled and the vendor has to apply for the license afresh (re-registration) with the approval of TVC.
- 10. Other Fees: The fee to be charged from registered street vendors other than vending fee, amenities, facilities and maintenance fee and penalties are as under:

12. Terms and Conditions:

- a. Venders having daily receipts of tehbazari will not be considered as registered street venders until and unless Venders are eligible as per vending rules/ scheme of HP and registered with SMC.
- b. Every registered street vendor shall be liable to pay monthly vending fee by 10th of every month online or in SMC office. Submission of fees is the responsibility and duty of street vendor and SMC is not going to collect if on daily bases.
- c. Vendors shall have options for payment at SMC office through digital mode of transaction i.e debit/ credit card or can directly transfer through net banking or cheque, in SMC/TVC account.
- d. The perishable items seized from un-registered street vendors will be donated to societies/charitable trusts/ashrams/hospitals/shelter for urban homeless, Old age home etc and non-perishable items will be disposed of by way of open auction by Shimla Municipal Corporation on monthly/quarterly/annual basis. No claim can be entertained by office as unauthorized vending is strictly prohibited.
- e. The registration will be valid for five years from date of registration of vendor.
- f. There will be 5 % annual compounded increase in the monthly street vending fees with effect from beginning of every financial year i.e. from 1st April.
- g. There will be discount in monthly vending fees of 25 % to disabled, single women and senior citizen vendors.
- h. The monthly vending fee will be deposited on monthly basis, if one would like to deposit on quarterly/half yearly/yearly basis then discount will be offered to the tune of $5\,\%$, $7.5\,\%$ and 10% respectively.
- i. Exemptions (maximum 50%) in the forms relief to registered street vendors in case penalties imposed will be given only when., the street vendor or his/her next kin shows valid documents of urgency i.e. hospitalization, pregnancy, death episode, accident or any extreme emergency due to natural or manmade disaster or riots etc. Such cases will be examined by nodal officer and will be decided at the level of Additional Commissioner/Joint Commissioner on recommendation of TVC. The maximum period for submitting claim for exemption/relief will be within six months from the date of last fee paid.

CHAPTER-IV

Procedure for Allotment of Vending Site.

- 13. The local authority through TVC shall adopt draw of lots procedure for allotment of vending sites in the designated vending zones. The determining terms and conditions for allotment of vending sites in the vending zone on first priority, will be for following registered street vendors:
 - a) Who had been surveyed and registered (provided with ID cards/COV) by the local authority in past will be Considered.
 - b) Who possess Himachal Pradesh based Aadhar cards.
 - c) Who submit undertaking to TVC that:

- I. He/she carry on business of street vending himself or through any of his family members whose names are entered during the survey.
- II. He/she has no other means of Livelihood.
- III. He/she shall not transfer in any manner whatsoever, including rent, the certificate of vending or the place specified therein to any other person.
- 14. TVC will give preference to reserved category (Max 24%) as per HP SV(Protection of Livelihood and Regulation of Street Vending) Scheme,2016.
- 15. All the surveyed street vendors who had been registered in the areas, which are declared as No Vending Zones will be relocated by the local authority for allotment of sites.
- 16. If the number of registered street vendors, identified in the survey are more than the holding capacity of the vending zone and exceeds the number of persons which can be accommodated in that vending zone, the TVC shall carry out a draw of lots for issuing certificate of vending for the vending zone, and the remaining persons shall be accommodated in any adjoining areas will be considered.
- 17. If number of registered street vendors is less than the number of the vending sites than the left over registered street vendors of adjoining sectors/areas will be considered.
- 18. If it is not possible to accommodate the registered street vendors as per the street vending zoning plan and the holding capacity of the that zone, than local authority will issue a computer generated acknowledgement of application specifying waiting list number.
- 19. If the street vendors who have been surveyed and wishes to do street vending, can get registered as a new registered street vendors based on the waiting list number to such persons whose application is excepted by TVC.
- 20. The mobile vendors will band from their allocated areas or where they have been surveyed until and unless they are not violating any norms of the Act. If they do so, then they will be shifted to nearby place as per vending zone norms. Such vendors can stay upto 30 minutes maximum at one place.
- 21. The Essential service provides (ESP) street vendors will band from their allocated area or where they have been surveyed until and unless they are not violating any norms of the Act. If they do so, they will be shifted nearby place as vending zone.

CHAPTER –V MISCELENEOUS

22. The Regulation of Traffic in the Vending Zone:- Wherever a vending zone is declared by the TVC the traffic police shall decide about one way traffic, vending timings, speed limit, parking movement of heavy vehicles etc. if traffic division doesn't agree with the vending zone, in that case it shall have to be shifted or cancelled in consultation with the TVC and Urban Development Department.

Local authority shall clearly earmark the vending area, footpath and cartage way with in the vending zone i.e. the circulation area.

- 23. The regulation of the quality of the product and services provided to the public in vending zone and maintenance of the public health, hygiene and safety standards:
 - a) Any vendors who sell food articles, readymade or processed on the street shall have to follow all the provisions of the food Adulteration Act 1954. In case of failure, penal measures shall be initiated by the concern department as prescribed in the Food Adulteration Act. If there is any conviction order from the concerned department, vending certificate of such street vendors shall be cancelled by the Local authority with immediate effect.
 - b) Quality of articles vended from the street can only be taken care of in case, there is a prescribed standard under a relevant status, and otherwise it will be only a qualitative assessment. In the absence of such standard it will be necessary to collect sample of such items against which some complaints are received by the vendors. Such cases can be discussed in the joint meeting of whole sellers, manufactures and vendors under the chairmanship of Commissioner to arrive at amicable solution.

(Explanation for example. Presence of toxic paint and sharp edges of the different part of the toy. There is a need for develop systematic samples taking an analysis of the same in an accredited laboratory. In case of proved presence of toxic element in the toys. The wholesaler should be compelled to take it back and payback the vendor price they pay if it not supplied on credit. In case of imported items found to be suffering from similar defects, vide publicity should be given drawing attention to the authorities empowered to take suitable "items.)

24. The regulations of the civic services in the vending zone : -

- a) The public toilet and drinking water facilities shall be provided at appropriate place by the local authority if there is unavailability:
- b) Proper collection of segregated solid waste management system have to be provided by the local authority on user charge basis but cleanliness of the allotted site is to be managed by the registered street vendors, no littering will be allowed.
- c) Lighting/power energy requirement to operate electric gadgets to the vendors shall be allowed by the solar or battery operated lamp mechanism.
- d) No individual's electricity and water connection shall be permitted in vending space.

25. Miscellaneous

- a) Commissioner/Chairman of the Licensing Officers may limit the time during which street vendors may be permitted to operate either generally or specially in respect of any class of articles or in any particulars public street with in the city.
- b) The license granted under those bye laws shall expire on complete of 5 years from the date of issue.
- c) The registered street vendors shall not do or permit to do negligent Act, likely to cause fire or otherwise endanger to the public safety.
- d) If the registered street vendors failed to comply with any terms and condition of this license, the commissioner or the authorized officer can revoke or suspend the license.

- e) If in case of registered street vendors reports of reduction in customer base due to relocation/displacement resulting into livelihood at stake, may inform the local authority for change in the location of vending. In such cases, the local authority may discus in the TVC for the potential relief (subject to maximum 1 relocation only).
- f) If the registered street vendors vacant to withdraw his/her license at any point of time, then he/she may submit an application in writing for discontinuation.
- g) Notwithstanding anything contained in these byelaws, the TVC may on compassionate ground in case of extreme hardship grant a certificate of vending to any person who is having severe disability of any type, HIV positive, senior citizen. Orphan, Poor/EWS widow and divorced women etc.
- h) In case the registered street vendor dies or become incapable of running his/her business on account of old age, infirmity, or any physical or intellectual disability as per requisite valid certificate from appropriate authority, the commissioner/licensing officer ma, for reasons to be recorded in writing, grant a license out of turn to his lineal descendant as per the act or the spouse. The lineal descendant or the spouse of registered street vendor shall intimate the local authority about such death, disability, infirmity or illness with valid document e.g. death, disability etc. in writing.
- i) The license/ Street Vender Shall always keep the license issued to him and shall on demand procedure it to the Commissioner/Chairman or the authorized officer.
- j) The license/street vender shall not transfer the license issued to any other person, without the prior written permission of the Commissioner/Chairman or the authorized officer.
- k) Every License issued to the street vender under these bye-laws may be renewed within 30 days from its date of expiry.
- 1) If the license/ street vender fails to comply with any terms and condition of the license, the Commissioner/Chairman or the authorized officer can revoke or suspend the license.
- m) In event of any future planning development of site/court order/directions, the allotted size is prohibited meant for vending; the registered street vendor shall not sell the articles in such prohibited site.
- In case of any change in future scenario, the byelaws may be amended with the recommendation of TVC and to be further notified.

Note: - The Local Authority may recommend to amend the bye-laws at any time as and when required in the public interest.
