The interested firms/parties are requested to send their quotations in sealed cover, duly addressed to the Commissioner, Municipal Corporation Shimla on or before 12th December 2024 at 03:00Pm in the O/o Joint Commissioner, Shimla, which will be opened on the same date at 3.00 PM by the tender opening committee under the Chairmanship of Joint Commissioner Shimla consisting of Executive Engineer (R&B), Accounts Officer and Supdt. General, MC Shimla.

**SCOPE OF WORK:**

1. Event Organization.
2. Conceptualize, plan and execute the "Voice of Shimla" music competition.
3. Manage Auditions, Semifinals and final rounds during the Carnival.
4. Revenue Sharing. The agency shall retain all publicity revenue.
5. The agency's bid should clearly outline the prize offered to the winner.

**TERM & CONDITIONS:-**

1. The interested firm/vendor must have wide experience in the respective field and shall submit in brief the details of events conducted by them in last three financial years. The rates quoted must be inclusive of all applicable taxes and GST charges. They shall submit their PAN No. copy and Income Returns of last three assessment years.
2. All the interested participants shall have to furnish as earnest money in the shape of Bank Draft of Rs. 25,000/- (Rs. Twenty five thousand) only in the name of Commissioner, MC Shimla and the earnest money shall be forfeited in case of non-appearance/non-performance of the artist in Winter Carnival Shimla-2024.
3. The successful party shall deposit a sum of Rs. 1,00,000/- (Rs. One lakh) only as security money immediately after finalization of the quotation and this amount will be refundable after completion of event.
4. The M.C. Shimla reserves the right to reject any/all tender without assigning any reasons. Any disputes arising shall be settled within the jurisdictions of M.C. Shimla Limit
