General, MC Shimla.

2. Conceptualize, plan and execute the "Voice of Shimla" music competition.
3. Manage Auditions, Semifinals and final rounds during the Carnival.
4. The Judges and Protocols will be appointed by the Winter Carnival Committee.
5. The agency's bid should clearly outline the prize offered to the winner.

The rates quoted must be inclusive of all applicable taxes and GST charges. They shall submit their PAN No. copy and Income Returns of last three assessment years.
2. All the interested participants shall have to furnish as earnest money in the shape of Bank Draft of Rs. 50,000/- (Rs. Fifty thousand) only in the name of Commissioner, MC Shimla and the earnest money shall be forfeited in case of non-appearance/non-performance of the artist in Winter Carnival Shimla-2024.
3. The successful party shall deposit a sum of Rs. 2,00,000/- (Rs. Two lakh) only as security money immediately after finalization of the quotation and the same amount will be refunded after completion of event.
