**TERM & CONDITIONS:-**

The interested firm/vendor must have wide experience in the respective field and shall submit in brief the details of events conducted by them in the last three financial years ( i.e.2021 to 2023). They must submit their PAN No. copy of income Tax Returns for the last three years, and GST registration.
2. All interested participants shall have to furnish an earnest money deposit in the shape of Bank Draft of Rs. 50,000/-(Rs. Fifty Thousand) only in favour of the Municipal Corporation, Shimla alongwith quotation.
3. The quotationer/party whose rates are accepted shall have to enter into an agreement with the Joint Commissioner, M.C. Shimla within 7 days of award.
4. The rates for each Artist/performer shall be accepted subject to the fulfillment of conditions mentioned above in Sr.No. 1&2.
5. The quotation shall be accompanied by the Bank Draft of the Earnest Money.
