

Deployment of Home Guards for implementation of directions passed by the Hon'ble High Court in CWPIL No. 14/2014 regarding regulating/controlling unauthorized vendors- Extension of period thereof.

Pursuant to the orders passed by the Hon'ble High Court in COPC No. 111/2019 dated 22.05.2015 and directions issued in CWPIL No. 14/2014 with respect to regulating/controlling unauthorized selling of goods/wares by hawkers, display of goods by shopkeepers on drain/public roads/path/streets in any bazaar within the Municipal Corporation area, the Municipal Corporation has approved the proposal for engagement of 10 Nos. Home Guards initially for a period of three months w.e.f. 21.07.2019 to 20.10.2019 vide Resolution No. 3(14) dated 30.08.2019 which was further extended upto 31.03.2020. Due spread of COVID-19, these Home Guards were repatriated to their Department. However, subsequently with the approval of Municipal Corporation Shimla obtained vide its Resolution No. 3(3) dated 27.06.2020, 4 Nos. Home Guards were deployed for the purpose in question for a period of six months commencing from July, 2020 and the same is going to expire on 23.01.2021.


The services of these Home Guards are still required by the Estate Branch, MC Shimla for further period of 6 months w.e.f. 24.01.2021 to 23.07.2021.
