- 11. The contractors/firms must give the copy of enlistment, G.S.T. Number, EPF Number & photocopy of individual/firm PAN Number allotted to them with their application at the time of applying for tender documents. Application will not be entertained without aforesaid documents.
- 12. The Contractors/firms will have to deposit 10% performance guarantee on awarded amount in shape of FDR before award of work.
