- 9. The contractors/firms must give the copy of enlistment, G.S.T. Number, EPF Number & photocopy of individual/firm PAN Number allotted to them with their application at the time of applying for tender documents. Application will not be entertained without aforesaid documents.
- 10. The Contractors/firms will have to deposit 10% performance guarantee on awarded amount in shape of FDR before award of work.
- 11. The intending Contractor/firm shall given an undertaking by way of affidavit duly attested and sworn before the Executive Magistrate or Notary Public clearly stipulating therein that he does not have more than two works in hand in the entire state of Himachal Pradesh and one of the work is nearing completion i.e. at least 90% of the tendered amount.
