- 6. BID OPENING DETAILS: The bids shall be opened on 27.02.2019 at 11.00 AM in the office of Executive Engineer, R&B M.C. Shimla H.P.by the authorized officer. In their interest the tenderer are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7. The bids for the work shall remain valid for acceptance for a period not less than 120 days after the deadline date for bid submission.
