2. **Availability of Bid Document and mode of submission:** The Bid document is available online and bid should be submitted in online mode on website:<https://hptenders.gov.in> Bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). "Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in Municipal Corporation Shimla may obtain the same from the website: <https://hptenders.gov.in> Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.

4. **TENDER DETAILS:** The Tender Documents shall be uploaded online in 2 Cover: (i) **Cover-1:** shall contain scanned copies of all "Technical Documents/ Eligibility Information". (ii) **Cover-2:** shall contain "BOQ/Financial Bid", where Contractor will quote his offer for each item.
5. **SUBMISSION OF ORIGINAL DOCUMENTS:** The bidders are required to submit (a) original demand draft towards the cost of bid document and (b) original bid security/Earnest Money Deposit (EMD) and other Technical Documents in O/o Executive Engineer, Road & Building Department M.C. Shimla, H.P. as specified in Key dates Sr. No. 4 on Tender Opening Date, failing which the bids will be declared non-responsive.
6. **BID OPENING DETAILS:** The bids shall be opened on 13.04.2021 at 2.00 PM in the office of Executive Engineer, R&B M.C. Shimla H.P. by the authorized officer. In their interest the tenderer are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

7. The bids for the work shall remain valid for acceptance for a period not less than 120 days after the deadline date for bid submission.
8. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to the tender.
10. The Contractors must maintain a wage register/Mustrol at the site of work place and it should be verified from time to time by the inspecting authorities, alongwith any award of work order/documents. Any default by the Contractors will render him in-eligible for future participation in the tendering process, for failure to comply with the mandate of the provident fund organization and for furnishing wrong information.
11. The Contractors must give the copy of Goods & Service Tax (GST) number, EPF Number, Labour Licence & photocopy as proof of individual/firm PAN Number allotted to them with their application at the time of applying for tender documents. Application will not be entertained without aforesaid documents.
12. E-tenders will be accepted from only those contractors who have successfully executed minimum civil/ similar work i.e. Supplying and installation of Outdoor Fitness Equipments to any Government/ Semi-Government Department or any other organization in last three years anywhere in India and having documentary proof of Quality Design Standard.
13. An affidavit to the effect that the Contractor has not been blacklisted by any Govt., Semi-Govt. Department, or any other organization.
