Terms and Conditions:-

- 2) The contractor/firm shall have to cover all the units daily falling which the penalty at the rate of Rs 50/- per unit/ per day shall be imposed by the C.H.O/ Commissioner M.C. Shimla
- 3) The contractor/firm shall maintain E.P.F/ESIC and other mandatory subscriptions for the labour and shall submit its record before 10 of every month.
- 4) Any penalty on account of default under provision EPF act, ESIC Scheme and other mandatory labour welfare rates, acts etc, shall be borne by the contractor. Firms.
- 5) The Commissioner shall be at liberty to terminate this agreement in case the performance of the contractor/ firm is not found satisfactory.
