SHORT TERM NOTICE INVITING QUOTATIONS


Sealed quotations are invited for providing and fixing Lighting/Illumination under the Winter Carnival Shimla 2025 to be organized w.e.f. 25th December to 31st December, 2025 (07 days) at the Ridge, Shimla. The interested firms/parties are requested to send their quotations in sealed cover, duly addressed to the Commissioner, Municipal Corporation Shimla on or before 10th December 2025 up to 11:00 PM in the O/o Joint Commissioner, Shimla, which will be opened on the same date at 3:30 PM by the tender opening committee under the Chairmanship of Joint Commissioner, M.C. Shimla consisting of Executive Engineer (R&B), Project Director, Accounts Officer, MC Shimla.

SCOPE OF WORK:

1. Installation of decorative warm white LED fairy artistic, vibrant and energy-efficient lighting illuminating lights in all the Heritage Buildings, Ornamental trees, railings, poles and surrounding areas of entire the Ridge and Mall Road from Shimla Club to SBI Kali Bari Chowk, Ridge towards Takka Bench & Ridge to Lakkar Bazar upto Police Chowki.
2. Illumination of main gates at 2 places, i.e. at CTO and Scandal Point.
3. Installation of Selfie points at 3 locations i.e. Scandal Point, Town Hall, and Shere-e-Punjab in front of Nathuram & Sons shop.
4. White colour Christmas tree about 10 to 15 ft height will be installed.
5. The scope of work may be increased or decreased as per requirement on spot.

TERM & CONDITIONS:

1. The interested firm/vendor must have experience in the respective field and should have a minimum annual turnover of Rs.1 Crore during the financial year. The rates quoted must be inclusive of all applicable taxes, GST and freight charges.
2. The rates quoted must be inclusive of all applicable taxes, GST and freight charges. The vendor shall submit their PAN No., copy of income tax return of last three financial years.
3. All the interested participants shall submit an Earnest Money of Rs.50,000/- (Rupees Fifty Thousand only) in the shape of Demand Draft as Earnest Money.
4. The successful party shall deposit a sum of Rs.1,00,000/- as security money immediately after finalization of the quotation and the same amount be refunded after completion of event.
5. The M.C. Shimla reserves the right to reject any/all quotations without assigning any reasons. Any disputes arising shall be settled within the jurisdiction of MC Shimla limit.
6. The firm/vendor whose rates are accepted as lowest shall be responsible for providing the required material with full installation at the venue. Winter Core Carnival committee will forfeit the earnest money as penalty if conditions are violated.
7. The Commissioner, MC Shimla shall be at liberty to arrange all such items from open market and any cost so incurred over the contract price shall be recoverable from successful quotationer.
8. The selection process will be two-fold: first, all eligible bidders will be required to give a presentation of their proposed lighting concept and execution plan. Only those bidders whose presentations are approved by the committee will qualify for the financial bid stage. Among the bidders shortlisted after presentation, the L-1 (lowest financial quotation) will be considered for award of work.
