Subject: Regarding Management of dead bodies of COVID-19 patients and last rites thereof.


A meeting regarding management of dead bodies of COVID-19 patients and last rites thereof in district Shimla was held on dated 19.5.20 under the Chairmanship of District Magistrate Shimla. Accordingly the SOPs regarding "Management of dead bodies of COVID-19 patients and final rites in District Shimla (HP)" were formulated and issued by the District Magistrate of Shimla.


As per the SOP, the personnel from Municipal Corporation Shimla shall remain present till the completion of the cremation of the dead body. The four personnel (two from Hospital and two from cremation/burial ground) who are physically dealing with dead body will be incentivized @ Rs. 2,000/- per body by the Municipal Corporation, Shimla. A detailed memorandum in this regard was placed before the Hon'ble House of MC Shimla vide Resolution No 3(21) dated 27.05.20 and was approved by the Hon'ble House.

There is no mention in the SOP for handling the dead body whose death occurs at home. Recently, the death of late Sh. Surjeet Singh occurred at his residence as D.S. Lodge, Annadale, Shimla and our three workers namely Sh. Pramod, Sh. Vikas and Sh. Vicky had to be deployed to physically deal with the dead body by putting into the Dead Body Bag and carrying up to the crematorium at Kanlog in an ambulance. The retrospective approval for distributing an amount of Rs. 4,000/- equally among these three workers may be approved.

Further, as the number of death cases is increasing day by day, the number of COVID positive death cases of home isolated persons may also increase in future. It is thus proposed that in addition to earlier approved incentives for the four persons handling such COVID positive patients (two from Hospital and two from cremation/burial ground), additionally incentives for two persons @ Rs. 2,000/- each per body for handling such COVID positive patients whose death occurs at their home may be given. They shall sanitize, wrap and put the body in the dead body bag and transfer the same up to the crematorium at Kanlog in an ambulance.

In view of the above, the matter is placed for the information, consideration and approval please.


As per the representations received from the hoteliers/ businessman regarding imposing of penalty in the bills of commercial establishments for Garbage User Charges, the surcharge/penalty was waived off vide resolution no 3(17) dated 29-12-2020 and also the consumers were allowed to pay the user charges in instalments.

Further, considering the recent surge in COVID-19 cases across the state, in order to contain the spread of COVID-19, directions were issued by the State Executive Committee(SEC) vide order No. Rev(DMC) (C) 20-2/2021-COVID 19-III dated 05-05-2021 regarding Corona Curfew w.e.f. 7th May,2021. Pursuant to these directions the Nigam Suvidha Kendra for offline service were closed due to which payments were restricted to online mode only.

Therefore, in order to avoid hardship to the consumers, it is proposed that initially the penalty/ surcharge on account of non-depositing Garbage User Charges may be waived off for the period of April ,2021 to June,2021.

Thus, the matter is placed before Hon'ble MC House for information and approval please.
